1. Q: Does this require any IDF/IC build outs?

A: No.

2. Q: Should lighting protection boxes be required on the OSP WAPS?

A: Yes. Provide lightning protection for Outside Plant wireless access points.

3. Q: Is there available space on the patch panels at each school to accommodate the requested cable?

A: The district has projected port capacity availability. It is recommended that the proposals include unit pricing for installed patch panels that meet or exceed the cable specifications incase closets are identified as requiring additional patch panel support.
